## 99.3 THE EAGLE'S "FACEBOOK" CONTEST Official Rules

A complete copy of these rules can be obtained by contacting radio station KWIC-FM ("Station"),825 S Kansas Ave, Ste 100, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website www.v100rocks.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.3 The Eagle's "Facebook"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 14 days or a prize valued at \$500 or more in the 180 days Void where prohibited by law. - (b) Comment on the Cosmic Chill Contest Post; and
- (c) Include #contest

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by Facebook will be deemed not entered in the Contest.

This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook. By submission of an entry, an entrant releases Facebook from any responsibility or liability for the

Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to Facebook.

- 4. Winner Selection. On or about 9:00am CST on August 15, 2022, Station will select fourteen (14) potential qualifying winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. On or about 9:00am CST on August 15, 2022, Station will select one (1) potential grand prize winner(s) in a random drawing from among all qualifying winners selected by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. The approximate retail value ("ARV") of each Qualifying Prize is TWENTY DOLLARS (**\$20).** 

The approximate retail value ("ARV") of each Grand Prize is TWO HUNDRED DOLLARS (\$200).

TOTAL ARV OF ALL CONTEST PRIZES IS: FOUR HUNDRED EIGHTY DOLLARS (\$480).

Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.
