99.3 THE EAGLE'S "SOCIAL POST" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KWIC-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.eagle993.com**, or by sending a self-addressed, stamped envelope to the above address.

Each winning entrant will be contacted using the Facebook post provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) HOURS of notification or failure to claim the prize within three (3) HOURS of verification and forfeiture of the prize.
