99.3 THE EAGLE'S "SOCIAL POST" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KWIC-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.eagle993.com**, or by sending a self-addressed, stamped envelope to the above address.

Eligibility. Failure to respond to the initial verification contact within three (3) days of notification and forfeiture of the prize.
