99.3 THE EAGLE'S "REMOTE DRAWING" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KWIC-FM** ("Station"), 825 S. Kansas Ave, Topeka, KS 66612, during available business hours Monday through Friday, on the Station website **www.eagle993.com**, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **99.3 THE EAGLE'S "REMOTE DRAWING"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. - 3. How to Enter.
 - Remote Broadcast: Attend a remote broadcast conducted by Station on December 9, 2024, from 5:00pm through 7:00pm at Sac & Fox Casino, 1322 US-75, Powhattan, KS 66527 and send a text message with the designated keyword given on-site and spelled correctly, to 877-297-1077. Limit one (1) entry per person per remote broadcast. All entries must be received by the deadline stated at the remote broadcast.
- 4. **Winner Selection.** On or about [10:00am] on December 11, 2024, Station will select one (1) potential winner(s) in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial

verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 5. Verification of Potential Winner.
